PUBLIC HEARING:

Williamsburg County has filed applications for grant and loan funds with the United States Department of Agriculture—Rural Development Community Facilities Loan and Grants Program. The purpose of the Public Hearing is to give an opportunity to the public to become acquainted with proposed Community Facilities projects consisting generally of 6 applications. These applications consist of the following: 1) The Williamsburg County Fire Department Radio Upgrade Equipment Project which will purchase 114 P25 Radios for the Fire Department to replace obsolete units. 2) The Williamsburg County Sheriff's Office Radio Upgrade Equipment Project which will purchase 89 P25 Radios for the Sheriff's Office to replace obsolete units. 3) The Williamsburg County EMD & EMS Radio Upgrade Equipment Project which will purchase 49 P25 Radios for the EMD & EMS Departments to replace obsolete units. 4) The Williamsburg County Aquatic Center Project which will support Michelle Obama's Lets' Move Project will construct an aquatic center to serve northeastern Williamsburg County. 5) The Williamsburg County Play 60 I Equipment Project which will support Michelle Obama's Lets' Move Project by constructing athletic fields and courts to serve northeastern Williamsburg County. 6) The Williamsburg County Play 60 II Equipment Project which will support Michelle Obama's Lets' Move Project and will construct tennis, basketball courts and playground equipment to serve northeastern Williamsburg County. Citizens will have the opportunity to comment on such items as economic and environmental impacts, service area and alternatives to the project. Projects funded by Rural Development are equal opportunity programs and discrimination in the program is prohibited by federal law.
