- ✦ **1<sup>st</sup> Reading** - Authorizing And Providing For The Issuance Of A Waterworks And Sewer System Revenue Bond, Series 2016a Or Such Other Appropriate Series Designation (St. Lawrence Water Project), Of Williamsburg County, South Carolina, In An Amount Not To Exceed \$3,455,000; Authorizing The County Supervisor And Chairman Of The County Council To Determine Certain Matters Relating To The Bond; Providing For Form And Details Of The Bond; Providing For The Payment Of The Bond; Providing For The Disposition Of The Proceeds Thereof; And Other Matters Relating Thereto.
